Looking back at 2016, we have a lot to be thankful for at Mount Nittany Health. The Mount Nittany Health Foundation's Grateful Patient Program was launched as a way to offer patients, their families and friends a way to say thank you for exceptional care they received while helping to make a difference in the lives of other patients. The program allows them to recognize outstanding care received and honor a physician, nurse, department or clinical program via donations to the Foundation. Gifts directly acknowledge a provider, team, or anyone who made an impression on the donor and helped to bring comfort during a time of need.

Longtime State College residents Doyle and Rebecca Corman were the first donors to the program after they both received excellent care at the Medical Center. They cited their appreciation for the patient-centered care that they received and their desire to ensure the continued advancement of the health system. Boalsburg residents Jim and Linda Gardner also made a Grateful Patient gift — along with a matching gift — to fund the purchase of new reclining chairs to the medical/oncology department, giving the gift of comfort to patients and their families, while honoring the individuals who cared for Linda during two hospital stays.

Last year's Golf Classic netted more than \$147,000, with all proceeds supporting the expansion of the Medical Center's cardiac catheterization services. Earlier this year, the Charity Ball raised a record-breaking \$200,000 for the Children's Advocacy Center. It was also announced last year that Lance and Ellen Shaner, longtime supporters of the Foundation, committed to the lead gift for an additional intensity modulated linear accelerator at the Lance and Ellen Shaner Cancer Pavilion. The second machine will improve access to radiation therapy for people needing this important facet of cancer care.

As you can see, philanthropy has tremendous impact on the services and programs and the patients they serve. So thank you to all of you for all of the ways you support Mount Nittany Health and the health and well-being of our community. We stand committed to our mission to make people healthier.
